Dothlatnak

- Phunzaihnak na tuahmi kongah biahnak ngeih dingah kan in pehtlaih te lai i thawngpaang tamdeuh pek dingah kan in fial men te lai.
- A tlangpi in, Kawmisin nih phunzainak na tuah hnawhmi minung asilole bu kha an pehtlaih hna lai i na phunzainak khawpi kha a pek hna lai. Na phunzainak ah a fiangmi thawngpaang le/asilole lehnak tuahmi pek dingah kan fial men hna lai. Na phunzainak lehnak ah Kawmisin sin i pekmi thawngpaang pawl ah zapi sin chim awk tha lo nangmah kong telhchih in pumpaak kong aa tel kho men.
